Important information to know before to completing this form -

Attention:

- 1. This form is not valid unless completed and signed.
- 2. A copy of the identification card for each party signing must be attached.
- 3. A copy of previous marriage or divorce documents must be attached, if applicable.
- 4. Consent of the father or grandfather is required for a virgin female, unless proof is shown that permission is not necessarily due to relinquishment of consent or death.
- 5. There should not be a live legal marriage document associated with the applicants.
- 6. There is a \$200 administrative fee for conducting the marriage contract or issuing the religious marriage certificate; however, gifts to the Imam conducting the marriage are also accepted.
- 7. Any information provided by the applicant in this form will not be disclosed to any third party without their consent unless disclosure becomes a religious or legal necessity. This application will not be returned to the applicant under any condition.

Major matrimonial rights according to Islam:

- 1. By matrimonial contract, it is the husband's obligation to afford suitable means of living that fits the wife's social status, including housing, food, clothing, and health care.
- 2. Both parties by matrimonial contract are entitled to kind treatment, respect, and good conduct.
- 3. Both parties by matrimonial contract are entitled to sexual intercourse, except with justifiable excuses.
- 4. By matrimonial contract the husband is entitled to compliance, obedience, coordination, and permission to leave the marital home, since the husband is obliged by Islam to manage the family and preserve its sanctity.

It is highly recommended for both parties to refer to jurisprudential sources, such as the *Islamic Laws* book, that reflect the view of the jurist (marja).

Matrimonial rights according to civil law in the United States:

The laws on marriage, divorce, wills, and inheritance in the United States may vary from state to state. Therefore, it is recommended to refer to a reliable source or consult a family law specialist to identify the different laws and regulations in respect to vital issue such as financial support; pre- and post-marital property; children and their rights; exercising personal freedoms during the marriage; and so forth.
